General Comments on Revenue and Expenses

- Offerings were above the 2020 levels however mainly due to a large one- off gift.
- Ministries revenue increase over 2020 level was mainly due to the Men's Shed activities which was offset by expenditure on the refurbishment of Sheds 11-13.
- Property revenue increased with gifts for the Rosebud re-development, and increased use on the Mt. Martha site with reduced lockdowns from covid19.
- Government assistance re covid19 ceased from March 2021.
- Ministry expenses increased with higher payroll costs and Men's Shed activities (offset in revenue).
- All Mission commitments were met in 2021

General Comments on Statement of Financial Position

- Cash reserves were of a similar level to 2020 however the amount held for the Rosebud refurbishment increased to \$506,635.
- The loan on the Mt. Martha property at the end of Dec 2021 was \$1,315,411, a reduction of \$121,555 during the year.
